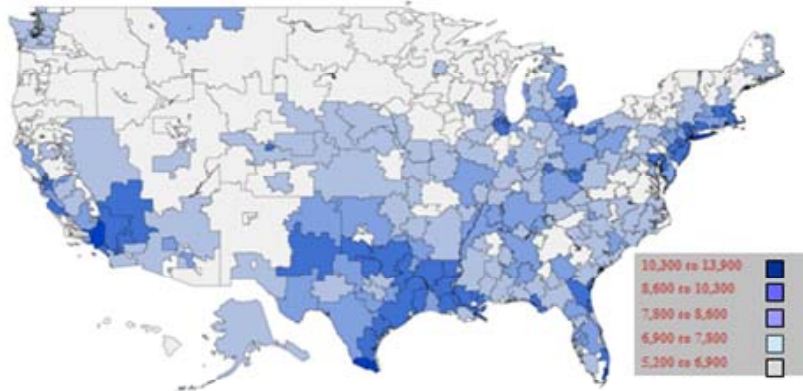

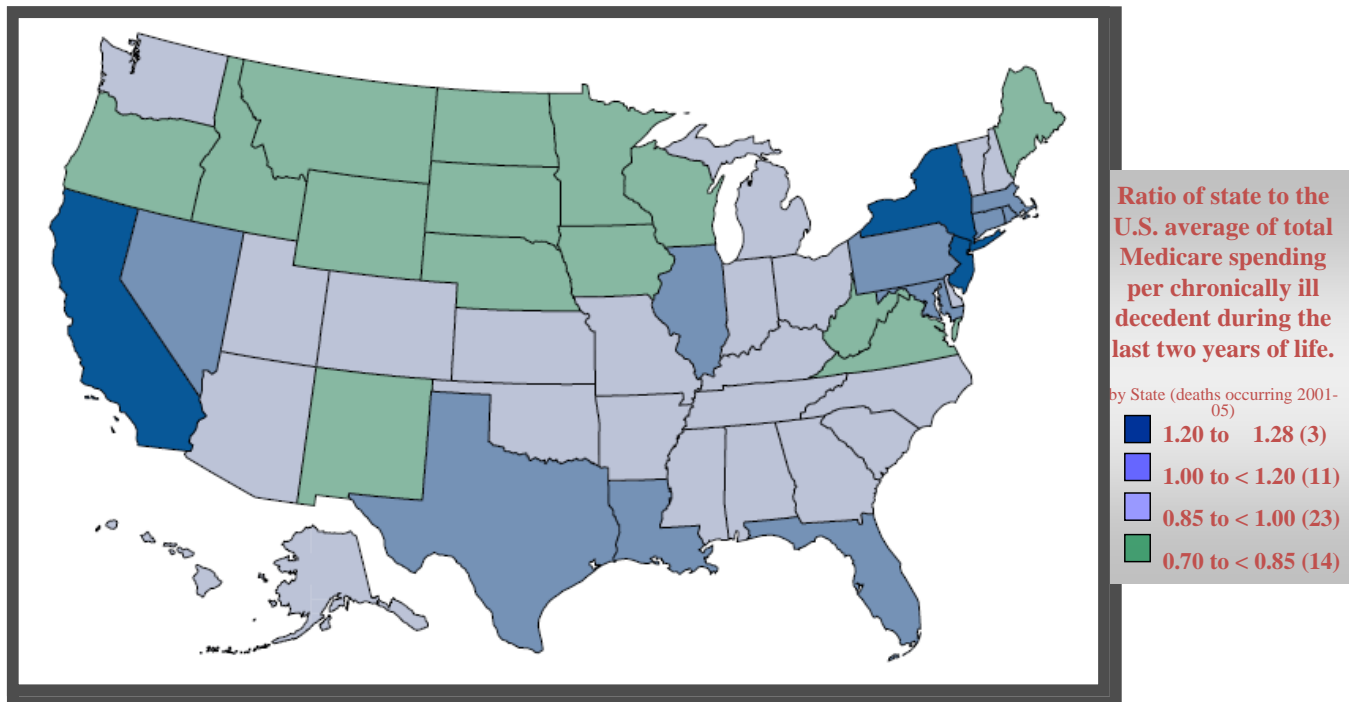

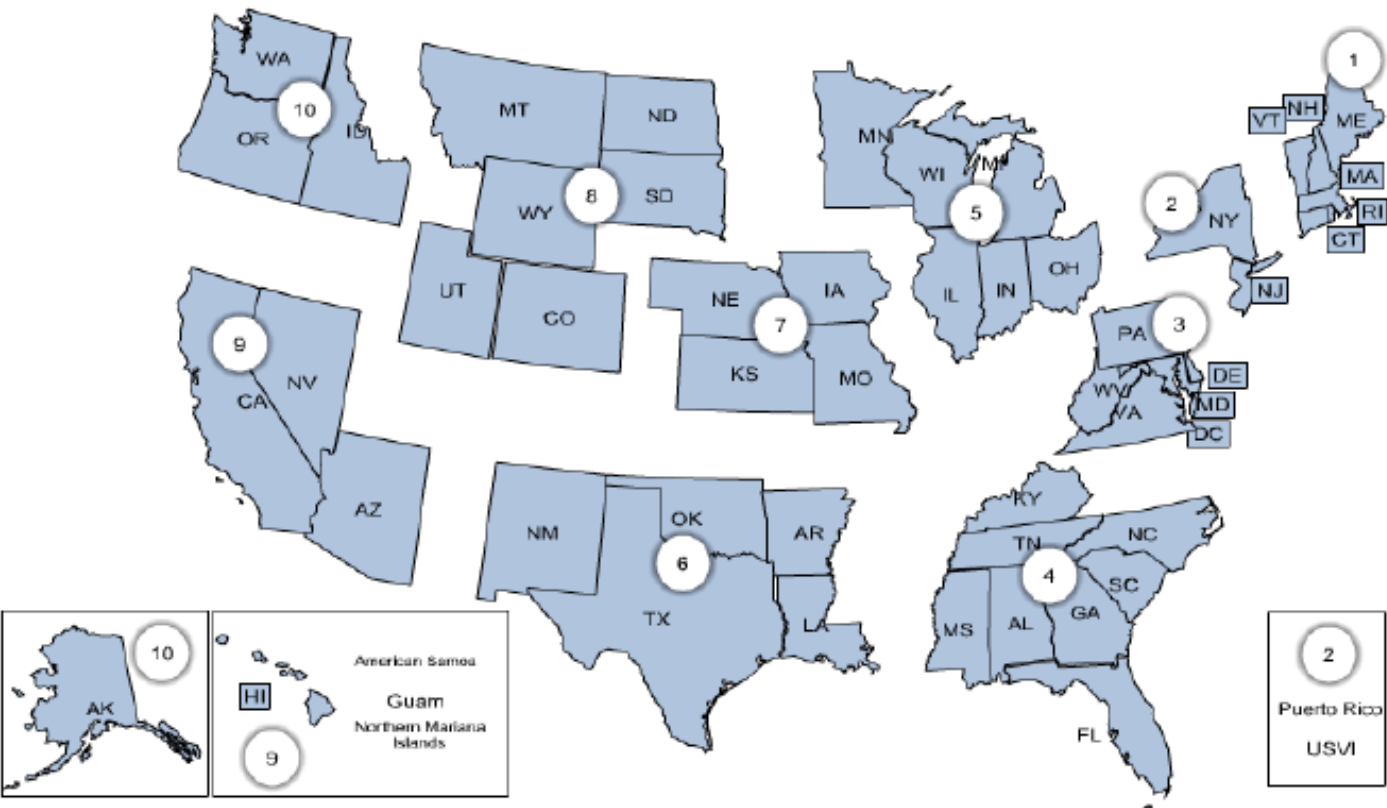
Medicare Spending Per Beneficiary, 2005



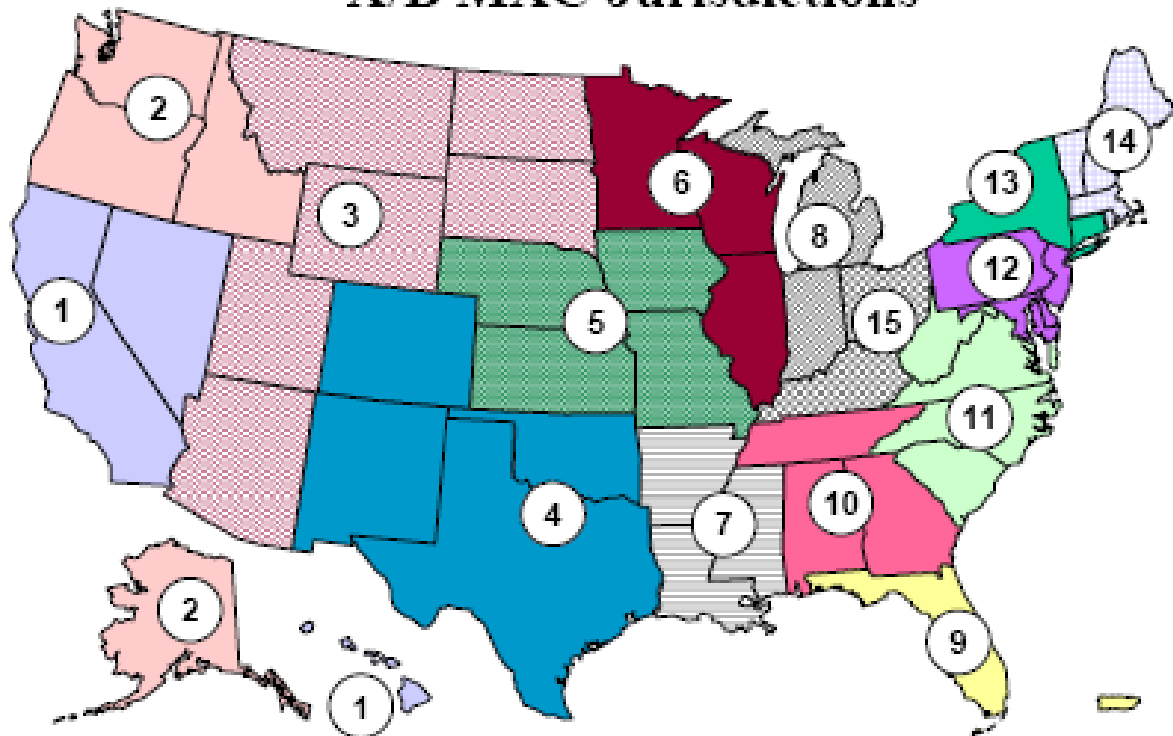
## Geographic Variation in Medicare Spending

### Medicare Spending During the Last Two Years of Life for Patients with At Least One of Nine Chronic Conditions

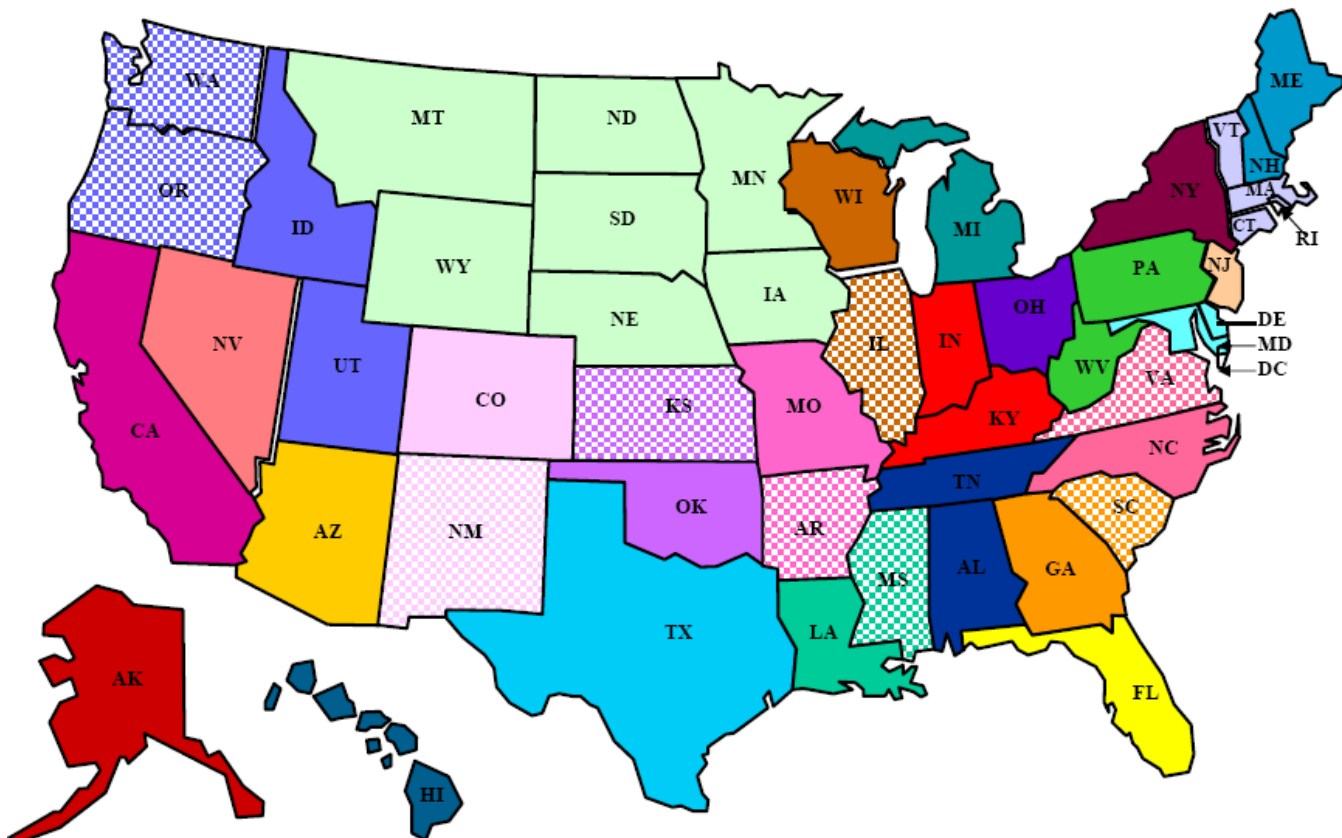




## A/B MAC Jurisdictions
